- 申请费用约RM 40 (10,306韩元)。
- 建议大家 can 提早申请,合格申请时效可长达两年,避免太迟有被拒的可能。
- K-ETA只能申请3次,但需重新付费。若3次都被拒的话,可到大使馆申请签证VISA,否则须等半年后才能再次申请。
- 使用App拍摄大头照时,背景必须是白色,越亮越好,照片大小必须是100KB以下
- 还没购买机票也可以先申请(建议买之前申请更安全,被通过后再预订);
- 有些人并没有收到邮件通知,建议随时到K-ETA网页查看申请状态。
- 申请通过后,记得将文件打印出来,方便机场检查。

- The application fee is around RM 40 (10,306 Korean Won).
- Apply in advance to prevent last-minute issues. Your application is valid for up to (2) years.
- You can apply up to (3) times, but each attempt requires a fee. If all 3 are rejected, consider applying for a regular VISA or wait for 6 months before reapplying.
- When taking your passport-sized photo, make sure the background is white, and the photo size is below 100KB.
- Apply before booking your flight ticket; it's safer that way.
- Check the website or app for approval notifications.
- After approval, remember to keep a hardcopy of your documents for airport checks.
